



Conditions of Participation Snack5 conference kit

1. Organiser

The organiser of the competition is the service office of the 5 am Tag e.V. association, Carl-Reuther-Straße 1, 68305 Mannheim, e-mail info@snack-5.eu, telephone +49 621 33840 114 (hereinafter referred to as the service office).

2. Participation free of charge

Participation in the competition is free of charge.

3. Right to participate

The right to participate is open to any natural person of full age who is not legally incapacitated and has his or her permanent place of residence in Germany or Austria (hereinafter referred to as "participant"). Minors are excluded from participation.

4. Participation

a) Competition period

Congress participants can take part in the competition from 15 June 2021 to 16 September 2021.

b) Conditions for participation

Congress participants can take part in the competition as part of their registration for the "European 5 a day Symposium".

In order to participate in the competition, the congress participant must complete the registration in full. By doing so, he/she accepts the conditions of participation, which he/she can view online at the congress registration.

c) In the case of winning

The winner will be informed of the prize by e-mail. The service office will send the prize by post to the address given in Germany or Austria. The legal process is excluded.

5. Prize

a) Winning

The first hundred registered participants for the "European 5 a day symposium" win a **Snack5 Conference kit with a small fruit basket and Snack5 pencil set**. No cash payment, change or exchange is possible. Winning claims are not transferable.





b) Determination of the winners

The winners will be chosen according to the entry of their full registration to the European 5 a day Symposium in the Zoom registration form. The first 100 registered participants win.

6. Exclusion of participants

The service office reserves the right to exclude participants from the competition if they violate these conditions of participation. Participants who use unauthorised aids or otherwise gain an advantage through manipulation will also be excluded. Participants who provide false personal details may be excluded from participation at any time. Participation via a competition service is excluded; only highly personal registrations are permitted.

7. Premature termination/ Reservation of right of modification

The Service office reserves the right to cancel or terminate the competition at any time and without giving reasons. Use will be made of this option if, for technical or legal reasons, proper implementation of the competition cannot be guaranteed.

The organiser reserves the right to change the design/conditions of the competition in the event of abusive behaviour or disruptions.

8. Limitation of liability

The liability of the service office is limited to intent and gross negligence. This applies in particular to failures of any kind caused by technical faults or caused by third parties and to other impairments in connection with the transmission and processing of information. The service office expressly advises the winners to observe the instructions for use of the respective product when using the products. The Service office shall not be liable in the event of loss of the prize in the post or any omissions or damage to the prize in the post.
